MUNICIPAL ORDINANCE NO. 2013 - 02

"AN ORDINANCE PROMULGATING THE RULES AND REGULATIONS ON THE ESTABLISHMENT OF PIGGERY WITHIN THE TERRITORIAL JURISDICTION OF KUMALARANG, ZAMBOANGA DEL SUR AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

Be it enacted by the Sangguniang Bayan of Kumalarang, Zamboanga del Sur in session assembled that:

ARTICLE A. TITLE AND SCOPE


Section 1A. <u>Title</u>. This Ordinance shall be known as: "An Ordinance Promulgating Rules and Regulations for the Establishment of Piggery within the Territorial Jurisdiction of Kumalarang, Zamboanga del Sur and Prescribing Penalties for Violations Thereof" or the "Piggery Ordinance of 2013".

Section 2A. <u>Scope</u>. This Ordinance shall regulate the establishment of piggery projects within the territorial jurisdiction of the Municipality of Kumalarang, Zamboanga del Sur and prescribing penalties for violations of the provisions of this ordinance, taking into consideration the sanitation and waste management of such establishment. It shall be the general objective of this Ordinance to allow a person or group of persons to engage in hog raising or piggery projects as an alternative source of income without causing any environmental pollution and health and sanitation problems.

ARTICLE B. DEFINITION OF TERMS

Section 1B. When used in this Ordinance, the terms shall mean the following:

- a. Backyard hog raising shall refer to the raising of not more than two (2) heads of swine or hog inside the residential area of the owner.
- b. Hog house or pig pen shall refer to the structure or building where the swine or hogs are raised, which shall have proper roofing, thick wooden or concrete siding with concrete flooring, provided with septic tank, and with good water supply.
- c. Piggery shall refer to the raising of swine or hog, whether for fattening or breeding purposes of more than two (2) heads.
- d. Septic tank shall refer to the waste depository which should have a manhole with a movable covering for easy scooping out of the deposited waste when the same shall be full.



ARTICLE C. REGULATIONS

Section 1C. No person or group of persons, firm, cooperative, or people's organization or association shall be allowed to establish any piggery within the vicinity of his/her residence located at the residential land use of densely populated areas in all of the barangays within the territorial jurisdiction of the Municipality of Kumalarang, Zamboanga del Sur.

Section 2C. Any person or group of persons, firm, cooperative, or people's organization or association shall be allowed to establish a piggery project, whether for breeding or fattening purposes, provided that the structure or pigpen shall be constructed or established within a distance of not less than five hundred (500) meters from the residential areas, such structure shall be equipped with the a septic tank having the following dimension: length of 4 meters, width of 2.5 meters and depth of 4.5 meters (4 m. x 2.5 m. x 4.5 m.).

Section 3C. Any person or group of persons, firm, cooperative, or people's organization or association that shall undertake a piggery project, whether small scale or large scale, shall not in any manner use or utilize the drainage canal, irrigation canal, stream, creek or river to drain off piggery wastes as prohibited by Republic Act No. 9003, otherwise known as the Waste Management Act.

Section 4C. The Municipal Health Officer and Sanitary Inspector are authorized to conduct inspection and verification in order to determine that such piggery house or hog pen is in accordance with the prescribed structure in relation to the compliance of health and sanitation condition and waste management as specified in this Ordinance.

Section 5C. The Municipal Planning and Development Coordinator and the Municipal Engineer shall likewise be authorized to conduct ocular inspection to determine that the physical structure of the piggery house or hog pen is in accordance with the recommended standard specification of such structure as provided in this Ordinance.

Section 6C. It shall be unlawful for any resident of densely populated barangays within the territorial jurisdiction of the Municipality of Kumalarang, Zamboanga del Sur, to raise swine or hog of more than two (2) heads at their respective backyard even if the said individual has complied with the requirements of the pig pen as provided herein. In no case shall any person or persons be allowed to undertake backyard hog raising by letting the hog wander anywhere, such that it can cause pollution which is deemed hazardous to human health as provided in Republic Act No. 9003.

Section 7C. <u>Penalty</u>. Any violation of any provisions of this Ordinance shall be penalized with a fine of not less than One Thousand Five Hundred (P1,500.00) Pesos for the first offense, a fine of not less than Two Thousand (P2,000.00) Pesos for the succeeding offenses, or imprisonment of not less than one (1) month, but not to exceed two (2) months, or both, fine and imprisonment, at the discretion of the Court.

ARTICLE D. FINAL PROVISIONS

Section 1D. Applicability Clause. All other matters relating to the imposition of this ordinance shall be governed by pertinent provisions of existing laws, rules, regulations and other ordinances.

Section 2D. Repealing Clause. All ordinances, rules and regulations or parts thereof in conflict or inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

Section 3D. Effectivity. This Ordinance shall take effect fifteen (15) days upon its approval, after posting for publication on at least three (3) conspicuous places of the Municipal Building, Public Market and Barangay Halls of Kumalarang, Zamboanga del Sur, or in a newspaper of general circulation in the locality.
