MUNICIPAL ORDINANCE NO. 2014 - 01

"AN ORDINANCE AMENDING PAR. (G) OF ARTICLE B. FEES AND CHARGES OF MUNICIPAL ORDINANCE NO. 2006 – 70, ENTITLED: " AN ORDINANCE REGULATING THE FEES AND CHARGES FOR THE USE AND UTILIZATION OF THE SERVICES OF THE MUNICIPAL MOTOR POOL AND HEAVY EQUIPMENT, FARM MACHINERIES AND SUCH OTHER MECHANIZED EQUIPMENT OF THE LOCAL GOVERNMENT UNIT OF KUMALARANG, ZAMBOANGA DEL SUR".

Be it enacted by the Sangguniang Bayan of Kumalarang, Zamboanga del Sur in session assembled that:

Section 1. Title. This Ordinance shall be known as: **"An Ordinance Amending Par. G of Article B-Fees and Charges of Municipal Ordinance No. 2006-70"**.

Section 2. Scope. This Ordinance shall amend Municipal Ordinance No. 2006 – 70, particularly **par. (g) of Article B** to include in this provision the rate of fees and charges for the newly acquired heavy equipment of the Local Government Unit of Kumalarang, Zamboanga del Sur.

Section 3. Fees and Charges for Heavy Equipments.

Type of Equipment	Rate per Hour	Rate per Day
1) Grader	2,500.00	
2) Road Roller/Compactor	2,000.00	
3) LGU Bus	-	4,000.00/day

Type of Equipment	Rate for the first 50 kilometers	Rate for the succeeding kilometers
3) Self Loading	P10,000.00	P100.00 per kilometer

Section 4. Other Provisions:

1. Self-Loading:
 - a. Fuel to be used shall be the responsibility of the leasee/user with a minimum fuel consumption of 1 liter for every 5 kilometers.
 - b. Oil and lubricants shall be provided by the LGU
2. Grader and Road Roller/Compactor:
 - a. Fuel to be used shall be the responsibility of the leasee/user
 - b. Oil and lubricants shall be provided by the LGU

3. LGU Bus:

- a. Fuel to be used shall be the responsibility of the user.
- b. Oil and lubricants shall be provided by the LGU.
- c. Minor repairs and maintenance while bus is on travel shall be the responsibility of the user.
- d. The user shall be responsible for the meals and allowances of the driver while the bus is on travel.


SECTION 5. EFFECTIVITY CLAUSE- This Ordinance shall take effect fifteen (15) days upon its approval, after posting for publication on at least three (3) conspicuous places on the Municipal Building, Public Market and Barangay Halls of Municipality of Kumalarang, Zamboanga del Sur, and/or publication in a newspaper of general circulation.

ENACTED AND APPROVED by the 8th Sangguniang Bayan of Kumalarang, Zamboanga del Sur on **September 8, 2014** during its 53rd Regular Session.


