**MUNICIPAL ORDINANCE NO. 2014 – 02**

**“AN ORDINANCE REGULATING THE OPERATION OF THE KUMALARANG SPORTS ARENA OF THE LOCAL GOVERNMENT UNIT OF KUMALARANG, ZAMBOANGA DEL SUR.”**

Be it enacted by the Sangguniang Bayan of Kumalarang, Zamboanga del Sur in session assembled that:

**ARTICLE A. TITLE AND SCOPE**

**Section 1A. Title.** This Ordinance shall be known as: “An Ordinance Regulating the Operation of the Kumalarang Sports Arena of the Local Government Unit of Kumalarang, Zamboanga del Sur”.

**Section 2A. Scope.** This Ordinance shall regulate the operation of the Kumalarang Sports Arena and the imposition of certain fees and charges through the Municipal Economic Enterprise Office for the rental of stalls or tables used for business and collection of parking fees.

**ARTICLE B. DEFINITION OF TERMS**

**Section 1B.** When used in this Ordinance, the terms shall mean the following:

- Bet – refers to the wager of money against someone else's on the outcome of a doubtful event on a cock fighting game.
- Cockpit – includes any place, compound, building or portion thereof, where cockfights are held, whether or not money bets are made on the results of such cockfights.
- Cockfight - refers to a game where two (2) fighting cocks are set loosed on a platform for a fight.
- Derby - refers to the cock fight where the game cocks are being weighed and matched in accordance with their weight with a fix amount of bet
- Friendly games – shall refer to the sports activities and games undertaken at the sports arena, using fighting or game cocks.
- Gaffer – refers to a person with knowledge in the art of arming fighting cocks with gaffs on one or both legs.
- Kumalarang Cockers Association – shall refer to the duly registered and accredited organization which will carry out and handle the different activities at the Kumalarang Sports Arena.
- Referee - refers to a person who watches and oversees the proper gaffing of fighting cocks; determine the physical condition of game cocks while cockfighting is in progress, the injuries sustained by the cocks and their capability to continue cock fighting, and decides and make known his decision either by work or gesture and result of the cock fight by announcing the winner or deciding tie in a contest game.
- Sports Arena – shall refer to the structure which is considered as a place for pleasurable



- j. Sultada – refers to each game released in a cockfight.
- k. Two-win game – shall refer to the fight using two gamecocks for every entry submitted by a individual or partnership o two or more persons which match is determine by the management
- l. Three-win - shall refer to the fight using three gamecocks for every entry submitted by a individual or partnership o two or more persons which match is determine by the management

## ARTICLE C. REGULATIONS

**Section 1C.** The Manager of the Municipal Economic Enterprise Office of the LGU shall be designated as the Administrator of the Kumalarang Sports Arena and shall take charge of the operation of the same, including the security of the facility, in coordination with the Philippine National Police (PNP) and other law enforcement agencies. He shall be directly responsible to submit a weekly report of collection and operational updates to the Municipal Mayor.

**Section 2C.** The Kumalarang Cockers Association shall handle the conduct of games and sports activities to be held at the Kumalarang Sports Arena in accordance with the rules and regulations authorized by the Philippine Amusement and Gaming Corporation (PAGCOR) and those authorized by the Local Government Units which has jurisdiction of such establishment. The same shall designate the cockpit manager or promoter, bet manager, gaffer (taga-tari), referee (sentinciador), bet taker, matchmaker and medical aide, who shall be required to secure the corresponding Mayor's permit.

**Section 3C.** There shall be collected certain fees and charges for some of the facilities inside the Kumalarang Sports Arena of the Local Government Unit of Kumalarang, Zamboanga del Sur, as follows:

- a. Fees for parking:
  - a. Single Motorcycle - Php15.00/day
  - 2) Motorcab/tricycle - 20.00/day
  - 3) Jeep, van, service vehicle (4 wheels) - 50.00/day
- b. Stalls/block tiendas:
  - a. Regular games - Php100.00/day/stall or table plus  
Php100.00/day/storeowner/tindera
  - b. Derby, Two-win &  
Three-win games - Php200.00/day/stall or table plus  
Php200.00/day/tinder
  - 3) Sports Arena - Php8,000.00/monthly  
with 1.5% increase for every 3 years

**Section 4C.** The Kumalarang Cockers Association shall be authorized to collect such other fees and charges, including but not limited to entrance fees, sultada fees and an equivalent percentage of the bet money, provided, however, that there shall be a sharing of the net proceeds per day of operation to be determined by the association and the Administrator which shall be embodied in a Memorandum of Agreement (MOA) to be entered into and between the Municipal Government of Kumalarang, Zamboanga del Sur and the Association.

**Section 5C.** All fees and charges authorized under this Ordinance shall be paid to the Municipal Treasurer or his duly authorized representative who shall issue an official receipt in acknowledgement of the payment received, except those which shall be collected by the Association.

**Section 6C.** All income derived from the operation of the Kumalarang Sports Arena shall accrue to the Municipal Economic Enterprise Office of the Local Government Unit of Kumalarang, Zamboanga del Sur.

**Section 7C.** Vendors shall be allowed to occupy the stalls or tables established inside the premises of the Kumalarang Sports Arena upon payment of the rental fee as provided in this Ordinance, however, in no case shall any vendor be allowed to bring their own tables or moving stalls inside the premises of the Kumalarang Sports Arena where their business activities will be undertaken.

ARTICLE D. FINAL PROVISIONS

**Section 1D. Applicability Clause.** Existing laws, ordinances, rules and regulations pertaining to the operation of the Kumalarang Sport Arena and its premises are hereby adopted as part of this Ordinance.

**Section 2D. Effectivity.** This Ordinance shall take effect fifteen (15) days upon its approval, after posting for publication on at least three (3) conspicuous places on the Municipal Building, Public Market and Barangay Halls of Municipality of Kumalarang, Zamboanga del Sur, and/or publication in a newspaper of general circulation.
