MUNICIPAL ORDINANCE NO. 2015-06

"AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF KUMALARANG, ZAMBOANGA DEL SUR IN THE TOTAL AMOUNT OF FORTY MILLION PESOS (P40,000,000.00) ONLY TO FUND THE REFINANCING OF LGU EXISTING LOAN BALANCES AND FOR THE PROPOSED IMPROVEMENT OF THE NEW MUNICIPAL HALL, THIS MUNICIPALITY.

Be it enacted by the Sangguniang Bayan of Kumalarang, Zamboanga del Sur in session assembled that:

Section 1. The Municipal Mayor Hon. Eugenio G. Salva, Jr. in representation of the Municipality of Kumalarang, Zamboanga del Sur, herein after referred to as the "Municipality" is hereby authorized to enter into a Refinancing Loan for LGU Existing Loan Balances with the amount of Twenty Million Pesos (P20,000,000.00) Only and for the proposed Improvement of the New Municipal Hall with the amount of Twenty Million Pesos (P20,000,000.00) Only, with the Municipal Development Fund Office (MDFO) of the Department Of Finance (DOF) in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the total amount of Forty Million Pesos (P40,000,000.00) Only, under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s, and subject to the requirements under Section 123of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Municipal Mayor shall have full power and authority to represent the Municipality of Kumalarang, Zamboanga del Sur, in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements, contracts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted;

*Proposed Municipal Ordinance No. 01-2015 "Creation of the Supplemental Plantilla Positions in the Office of the Municipal Treasurer, this LGU":

> Hon. Francisco H. Maca, Jr. presented and read the proposed ordinance on the Creation of the Supplemental Plantilla Positions in the Office of the Municipal Treasurer, this Municipality. He further presented the reasons of the said proposed ordinance, and accordingly, the creation of additional plantilla positions in the Office of the Municipal Treasurer, this Municipality is necessary to address the request of the Municipal Treasurer. The Municipal Treasurer is requesting for additional employee in order to strengthen the collection of the LGU's income and to have a full force team to facilitate and supervise the massive collection strategy.

*Proposed Municipal Ordinance No. 02-2015 "Regulation on the Traffic and using the appropriate muffler and allowing the single motor or habal-habal to pick-up passengers as the case maybe in the Mun. of Kumalarang, ZDS:

> Being the author of this proposed ordinance, Hon. Francisco H. Maca, Jr. gave the rationale of this proposed ordinance. He further explained every details of the content of the ordinance and addressed the participation of the Motor Driver's Association in the implementation of this ordinance.

*Proposed Municipal Ordinance No. 03-2015 "Regulation of the Speed Limit from 50km per hour to 60km per hour within 1710 to 1712 km in the National Highway, Kumalarang, ZDS, and vice versa:

> This proposed Ordinance was again presented by Hon. Francisco H. Maca, Jr. He made his explanation with every detail within the Ordinance. He also signified the importance of this ordinance since the main purposed is to avoid accidents most especially in the national highways.

*Proposed Municipal Ordinance No. 04-2015 "Establishing the Barangay Dengue Task Force (BDTF), defining its powers and duties and providing penalties for violation hereof:

> The Chairman, Committee on Health Services, Hon. Althea Gleene A. Poliran presented this proposed Ordinance. She explained the details of the proposed ordinance; accordingly, the main purposed of this ordinance is to have a functional Barangay Dengue Task Force (BDTF) since this is the most effective and cheapest way for the prevention and control in the spread of Dengue Fever in the Municipality of Kumalarang in the coming years. She also emphasized the functions and responsibilities of the BDTF.

> *Proposed Municipal Ordinance No. 05-2015 "Fisheries Code of the Municipality of Kumalarang, Zamboanga del Sur - NIPAS National Integrated Protected Areas:

> Again, Hon. Francisco H. Maca, Jr. presented and read this Ordinance and gave its rationale and the important details of each section in the ordinance. He was also given emphasized on the importance of the Registration of the Municipal Fishers.

Section 4. The Municipality of Kumalarang, Zamboanga del Sur hereby appropriates the entire proceeds of the borrowing exclusively to finance the Refinancing of LGU existing indebtedness and for the Improvement of the New Municipal Hall and other financial obligations relative thereto.

Section 5. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

Section 6. This Ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an ordinance for its validity, including the affixation of signatures of the Sangguniang Bayan Members, in concurrence thereto, composing at least a majority thereto, out of the total of Ten (10) Members, on all the pages of this Ordinance.

Section 5. Effectivity. This Ordinance shall take effect upon its approval.

SO ORDAINED/ENACTED.

RESOLVED FURTHER, that copies of this Ordinance be furnished to the Honorable Mayor, Municipal Accountant, and the Municipal Auditor, all of this Municipality, Province of Zamboanga del Sur and the Bangko Sentral ng Pilipinas for their information and appropriate action.
