HOLOYOHAY, CESO V, REGIONAL EXECUTIVE DIRECTOR, DA REGIONAL FIELD UNIT IX, LINIENZA, PAGADIAN CITY, TO ALLOCATE FUNDS FOR THE REHABILITATION OF THE FARM TO MARKET ROAD FROM SITIO SAYAO, BARANGAY POBLACION TO BARANGAY LANTAWAN, KUMALARANG, ZAMBOANGA DEL SUR.

WHEREAS, presented for request of the constituents of Barangay Lantawan, this Municipality, for the rehabilitation of the farm to market road project taking into consideration that upland farming is the main livelihood of the residents; and
