RESOLUTION NO. 347 S. 2012

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALLAN P. DAMAS, REE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) FOR THE IMPLEMENTATION OF THE PHILIPPINE REFERENCE SYSTEM OF 1992, KNOWN AS THE "ADOPT-A-MOJON" PROJECT IN THE MUNICIPALITY OF KUMALARANG, ZAMBOANGA DEL SUR.

WHEREAS, in cognizant to the provisions of Executive Order No. 45, series of 1993, as amended by Executive Order No. 280, series of 2000 and Executive Order No. 321, series of 2004, providing for the Philippine Reference System of 1992 (PRS 92), the Municipal Government of Kumalarang, Zamboanga del Sur is giving favorable consideration of the said national proclamation; and

WHEREAS, in the implementation of the said program, there is a need to grant an authority to the Local Chief Executive of this Municipality;

NOW THEREFORE, on motion of Hon. Francisco H. Maca, Jr., seconded unanimously, it was;

RESOLVED, as it is hereby resolved, to authorize the Local Chief Executive, **HON. ALLAN P. DAMAS**, **REE**, to enter into a Memorandum of Agreement (MOA) with the Department of Environment and Natural Resources (DENR) for the implementation of the Philippine Reference System of 1992 for the Municipality of Kumalarang, Zamboanga del Sur;

LET COPIES, of this resolution be furnished to DENR, through the Regional Executive Director, DENR Regional Office No. 09, Zamboanga City, and to all concerned, for information and appropriate action.
