RESOLUTION NO. 63 S. 2023

"A RESOLUTION REQUESTING THE SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) HON. AMENAH P. PANGANDAMAN FOR FUNDING ASSISTANCE UNDER THE LOCAL GOVERNMENT SUPPORT FUND PURSUANT TO R.A. 11936 GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2023 FOR REHABILITATION OF CONCRETE PAVEMENT ALONG DIPLO-KITAAN-DAGAT ACCESS ROAD (KITAAN-DAGAT SECTION) AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000.00)"

WHEREAS, in the declaration of Principles and State Policies enshrined in the Philippine Constitution, Article 2, Section 5 provides the maintenance of peace and order, the protection of life, liberty and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 17 (a) of the R.A. 7160 otherwise known as the Local Government Code of 1991 states that Local Government Units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities enumerated therein;

WHEREAS, there is a necessity to rehabilitate the concrete pavement along Diplo-Kitaan-dagat access road (Kitaan-dagat section) as it poses difficulty to the constituents of such barangays in terms of travelling and transportation of goods, commodities, agricultural produce, aquamarine products, etc.;

WHEREAS, this august body deems it necessary to request the Department of Budget and Management (DBM) for the rehabilitation of the abovementioned concrete pavement so as to ensure that the constituents of such areas are well-reinforced especially in the aspect of accessibility and transportation convenience and safety;

NOW THEREFORE, on motion of Hon. Alexis G. Elumba, seconded by Hon. Lorenzo C. Gomomit, Hon. Rolando O. Jayme, Hon. Abdulgani L. Edris and Hon. Sandy P. Bualan;

RESOLVED, as it is hereby resolved to REQUEST THE SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) HON. AMENAH P. PANGANDAMAN FOR FUNDING ASSISTANCE UNDER THE LOCAL GOVERNMENT SUPPORT FUND PURSUANT TO R.A. 11936 GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2023 FOR REHABILITATION OF CONCRETE PAVEMENT ALONG DIPLO-KITAAN-DAGAT ACCESS ROAD (KITAAN-DAGAT SECTION) AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000.00).
