RESOLUTION NO. 69 S. 2023

"A RESOLUTION REQUESTING THE SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) HON. AMENAH P. PANGANDAMAN FOR FUNDING ASSISTANCE UNDER THE LOCAL GOVERNMENT SUPPORT FUND PURSUANT TO R.A. 11936 GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2023 FOR THE CONSTRUCTION/REHABILITATION OF PUROK KAUMAHAN A FLOOD CONTROL ALONG SECADE RIVER AT BARANGAY POBLACION, KUMALARANG, ZAMBOANGA DEL SUR AMOUNTING TO FIFTEEN MILLION PESOS (PHP 15,000,000.00)"

WHEREAS, Section 2(a) of the R.A. 101211 states that it shall be the policy of the State to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, Kumalarang has been mapped out as one of the most susceptible municipalities to disasters and calamities such as flash floods, landslides, storms, typhoons, etc. in the province of Zamboanga del Sur;
